- Suggested to look at section 19-22 in document he forwarded to VFCYJC
- Suggested registering volunteers and insuring volunteers who are subcommittee volunteers
- October 1 is when you need to get your budget in
- VFCYJC records will be stored by CRD in future
- Commission bylaws can be changed in the future.
- Directors and Officers would not need insurance as you are covered by Local Government Indemnity Act.
- If Delegated Bylaw adopted in future VFCYJC might not need Constitution and Terms of Reference.
- There are no requirements to have a certain number of people on a commission.
- The Governance Committee is very pleased how review is going.

A member stated that Mr. Carey is the CRD Lawyer and not the lawyer for the Victoria Family Court and Youth Justice Committee.

The VFCYJC thanked Mr. Carey for his continued advocacy for our committee.
